Moderator

Kathleen Styles

I surprised myself by enjoying my term as moderator! Honestly, I only agreed to do this because someone used the word "beseech," but it's been fun and I am so pleased at the direction our church is taking.

This has been a year of big changes for Little River, the two biggest changes are the arrival of our new senior pastor and the return to full operations after COVID. We moved a long way to full operations in 2022,



but only in 2023 did we become mask optional and only in 2023 did our attendance return to pre-COVID levels. We began the year with uncertainty about our search process. We give thanks to Pastor Art for agreeing to stay with us through our full interim period, and we are joyous at the arrival of Shelli, our new senior pastor, in May. Shelli hit the ground running, and we are the better for it.

As moderator, I thought my two biggest tasks this year were to manage the work of the Church Council, hopefully making it a little less onerous to be in church leadership, and to make the transition to our new pastor a smooth one. The transition process included working with our Search Committee to manage the call process (once they recommended a candidate), fretting about a lot of small details related to onboarding (yes, we had a checklist!), arranging for guest pastors for our in-between period, helping Shelli learn about us, and helping set up a Pastoral Support Committee for her.

We made some changes in the way we run Council this year. While we generally meet via Zoom, we now meet once a quarter in-person for a potluck lunch + business. Instead of having updates at the meetings, we moved to a model where each board or committee sends a written update prior to the meeting, freeing up Council time for discussion. A bonus is that I can use those updates to prepare a detailed update for the monthly newsletter. We moved to using an online "planning calendar" to keep track of activities and reduce the number of scheduling snafus. It's not a perfect system, but it seems to help. I continued Clark's tradition of attending the staff meeting monthly, shortly before the Council meeting, to facilitate two-way communication.

Mostly, I'd like to celebrate our church's return to business as usual. I am so glad to see families back in worship and attending church functions. We're back to having coffee hours, picnics, the Service of the Gift, and full Christian education activities. It is important that we continue to offer hybrid worship, and I am proud of

the Media Team and their flexibility and good humor, which makes this possible.

HR Committee

The HR Committee consists of the moderator team, the senior pastor, the chairs of the Board of Deacons and the Board of Trustees, and the treasurer. We meet once a month—or as needed—to manage our personnel. As the year has progressed, we've come to the conclusion that we don't need the treasurer in the committee, so we will be moving to remove this requirement from our bylaws. Given the participation of the chair of the Board of Trustees, the treasurer will be consulted as needed, should any financial information be necessary.

One of the committee's functions is to ensure that reviews happen and are meaningful. We conducted regular reviews with Pastor Art, and the committee is preparing for our first review with Shelli in January 2024. We're trying to use a deliberate and thoughtful process, a process that will likely evolve as her ministry with us continues. Staff reviews are generally up-to-date, and those that are not will become so early in 2024.

During our interim period, the committee oversaw the hiring of a new building and grounds manager and a CE aide to assist the child care provider. We discussed 2024 salary levels and the cost-of-living increase. We reviewed and updated the Employee Handbook.

Senior Pastor

The Rev. Dr. Shelli M. Poe

I've been serving Little River for eight months now. It's not a long time, but it's long enough for me to have learned a few things about this community.

Our congregation is blessed with

people who are passionate and compassionate.

Creating content for our new Welcome Packet for newcomers and our Stewardship Booklet along with attending our boards and committees has offered me the opportunity to learn about the deep commitments we share, commitments to feeding, clothing, and giving to the impoverished; to striving to become

antiracist; to ministering with and to the LGBTQ community; to a lifetime of learning; to the joy of making and listening to music; to caring for women; and to supporting interfaith dialogue and our Afghan, Palestinian, Jewish, and other neighbors. We are a congregation of deep passion and commitment, and I'm looking forward to the ways we will continue to turn our values into action.

Our congregation is full of people with open minds and open hearts.

When I introduced a congregational response into our prayer time, we laughed together on those occasions when I forgot to do it myself, and we have had patience with one another as we learn a new habit. In our Tuesday Discussions,

I've been able to lead conversations about Antiracism and Black Theology, Feminist Theology, and Womanist Theology, and I've been consistently and pleasantly surprised by the group's honesty and openness in learning together. I am looking forward to

our Strategic Planning process this year. The process will draw on our open mindedness, our flexibility, and our creativity as we envision Little River's future.

We have a vibrant and growing group of children and youth.

I have the pleasure and priva

sure and privilege of talking with our younger worshipers each week during

worshipers each week during
Children's Time and with our
youth during Confirmation after
worship. Children and youth now
have their own designated tables at
Coffee Hour, and how wonderful it
is to see them creating community
together each week. Our children
are our future; and the future is
very bright.

Our congregation is eager to engage with the wider community and to welcome newcomers.

Since I arrived, we have become an organizational member of the Interfaith Communities for Dialogue, whose board includes members of many of our ecumenical partners in the Christian community as well as folks from Jewish, Sikh, Muslim, Baha'i, and more traditions. We have also had a presence at NOVA Annandale's "NOVA Day," dropped off meals for the LGBTQ+ small group led by Arise Campus Ministry, walked in the DC Pride Parade, supported our Scout Troop and Pack, and held a very well-attended churchwide and collaborative Trunk or Treat Festival. In addition, we've been discerning whether we might strengthen our ties with UCC of Fredericksburg by sharing our adult education opportunities and other resources with them and learning from their community.

I could go on.

Beloved, in covenant faithfulness, we now walk together into 2024. We will meet new challenges, creatively forge new paths, deepen our core identities, and live in community with one another under the guidance of God in Christ. In this new year, may we rejoice in our community – this beautiful and beloved body of Christ.

Communications & Music

The dual role of communications and music, I like to tell folks, provides Little River some economies: I don't have to email music for the bulletin to anyone, and I have a long-range idea of upcoming events and services that speeds planning. It also, on the flip side, lets me add layers of frosting and sprinkles (descants, faux bourdons, fancy fliers, anyone?) to cupcakes that

are already tasty.

Working directly with the Sanctuary Choir and the Handbell Choir are perpetual delights. We have a lot of fun, stretch ourselves musically and mentally, and provide near-weekly worship leadership in music. While

selecting anthems that fit the season and the scripture (and, we hope, the sermon!) is rewarding, presenting larger works provides an opportunity for focused study, development of new or lapsed skills, and a sense of accomplishment. In 2023, the Sanctuary Choir sang the Solemn Mass by famous organist Louis Vierne in Lent. In Advent, at the urging of several choir members, we revisited Antonio Vivaldi's *Gloria*. To be honest, I took it as a challenge to find new things in the score or to highlight unexpected motifs to keep it fresh. For example, consider the soprano's 4-3 suspension in measure 6 of the "Gratias Agimus Tibi" (borrowed, in full disclosure,

from another performance).

Each year I must give thanks for the support of Little River for guest musicians, and 2023 was no different. The Gloria was supported by a string quintet along with our own trumpet, oboe, and organ players. Earlier in the fall, to perfect a lovely contemporary anthem, *Shalom*, Kelly Cho joined us on violin and provided more of those am delighted she has enough singers for the first time since COVID to present a musical in Lent 2024.

I also continue to enjoy contributing to the liturgical life of Little River beyond music. As the longest serving current staff person, I get to remind us of traditions such as the candle lighting for All Saints Day, the crèche and Advent wreath, palms for the

> procession on Palm Sunday, candles for the Seven Last Words on Good Friday, and, yes, how far down the hallway do Mary and Joseph and the magi move each week in Advent.

On Palm Sunday, I got to organize the "scripture

chorus" for the Passion narrative, and a few weeks later guest preacher Karen Byrne requested a similar reading of the Creation account; I don't think we'll forget the booming, disembodied voice of God that morning!

Collaborating with ministers and guest preachers also feeds my creative side. On the Baptism of Jesus Sunday, Pastor Art and I worked a "Remembering Our Baptism" into time with children, assisted by fronds to asperge (or sprinkle) the congregation. For MLK Day, we presented Pastor Art's play about King and Bonhoeffer; this re-imagined the chancel space and stretched our media team. Building Native American music through



"sprinkles" throughout the service on the prelude and hymns.

Our own members play frequently, and I am grateful to Amanda Halstead, Tracey MacDonald, Brian MacDonald, Robin Petrusak, Jody Walker, and Jessica Sammis Nilles. Our youth have also been active musicians: cello, piano, ukulele, flute, as well as percussion and Orff instruments and singing. Thank you!

My colleague in crime, Ashton Streavig, impressively leads the Salt of the Earth and Joyful Noise choirs, conducted the brass at Easter, filled in with the sanctuary choir, and substituted for me while I was on vacation. Her talents are nearly endless, and I worship for Indigenous People's Day and music (organ, choral, and hymns) from around the globe for World Communion Sunday grows our musical appreciation as well as our being citizens of a single Earth. Sometimes the collaboration is more roasting: for Pastor Art's final Sunday, the music included *Two Trumpet Tunes from "King Arthur"* and "How Great Thou Art," as well as favorites "Leaning on the Everlasting Arms" and "Siyahamba." That service concluded, still online, outside at the Table the Scouts created for a worship space.

Speaking of which, the media team continues to grow both in numbers and in talent. More complicated or creative services no longer surprise or trip up our volunteer team—some even cherish those services!—and including slides of books for Time with Children or prerecorded portions of liturgy or sermons (Sallyanne Harper, Professor Maulana Karenga, Ms. Helen Beebe, and the late Fran DuRocher all

come to mind). Our online community has continued with strength and with time-to-time members as folks travel or just want a Sunday morning at home. We took full advantage of this with a virtual-only service for Advent IV so we could all gather later in the day to celebrate Christmas Eve.

During 2023, Jay Shackley came on board as communications assistant. His primary duties focused on leading the media team every Sunday and providing technical expertise for audio and video; refreshing the website post-COVID and with the arrival of Pastor Shelli; and bringing life to an active social media presence for the church. If you think back, Jay took our Facebook and Instagram pages from reminding the world that we have

a sermon every Sunday morning to showing all the ways LRUCC is active in ministry and being Christ's hands in our community. Jay excelled at all of these, and his work on the media team and social media will continue in 2024.

Jay (and his father, Ken Shackley) have also been key to including the online community in events in the social hall: the Lenten series, Pastor Art's farewell, and the Spiral Walkfocused service, to name a few. Running cables, a little soldering, lots of testing, learning how far the wireless



mics reach, not to mention running cameras and audio (thanks, Dave Shepherd!) are all key to keeping our Little River community all together, whether in-person or online.

Communications is a team effort, with the Communications Committee, Jay, and, of course, Kathy Heyman providing constant and high quality input and execution. We printed and mailed seven issues of *Current Reflections*, maintaining a balance of editorial content, long-range event announcements, and colorful and photo-rich coverage of recent programs, services, and ministries—along with regular updates on building and grounds issues and the work of the committees and boards. We also sent weekly e-communications (*Current*

Tidings), e-mail alerts as needed, and service reminder e-mails.

Soon after Shelli's arrival, we started producing two versions of the bulletin. One, the "bulletin," contains the order of worship, announcements, calendars, and music. The other, the "missal," contains all the scripture passages and words for the liturgist as well as generous hints for the video and audio operators at the media team so we (almost) never miss a shot or a word. If you ever see a copy lying around after a service, take a look at what goes on behind the scenes.

Working closely with committees and committee chairs has also enhanced LR communications this year. Whether confirming talking points for a Moment for Mission, printing posters, updating the bulletin board, or helping design the materials for the stewardship campaign or the Trunk or Treat event, it is an honor to contribute to Little River through design, content, photography, advertising (especial-

ly Spring Fling and Trunk or Treat), and electronic outreach.

Also on the creative side, Pastor Shelli has been a champion of fresh, current exhibits on the walls of the main hallway and of regular communications on bulletin boards. This is especially true of the strategic planning exhibit in the social hall and the rotation of banners on Little River Turnpike.

I know I've omitted many exciting and worthy parts of 2023 (such as the return of the Steinway piano and exploring new hymns and composers!) and I fear lest I've not mentioned vital partners. But know this: I am grateful for the opportunity, for the work, for the collaboration, and for all each of you bring.

Calendar year 2023 was a busy year for the LRUCC Board of Deacons. No one on the Board felt able or ready to take on all of the responsibilities and time commitment to serve as the chair for the year after Drew Nettinga's term ended at the 2023 Annual Meeting, so some of us agreed to rotate the duties monthly.



In January 2023, LRUCC continued with Interim Senior Pastor Art Cribbs in the pulpit. Hybrid worship continued throughout the year, allowing people to continue worshiping via Zoom if unable or unwilling to attend in person. The Board of Deacons continued to hold Zoom meetings at 7 P.M. on the first Tuesday of each month, with a couple of exceptions. In 2024, we will continue to meet on Zoom, but our meetings will change to 7:30 P.M. on the first Monday of the month (second Monday for January and September due to holidays).

In February, Kathleen Styles and Rich Dodenhoff coordinated a successful Shrove Tuesday Pancake Supper for the congregation. Rich made his popular chocolate chip pancakes, as well as chip-free pancakes. This had been a very popular event before the pandemic. It was great to revive this fun event.

For Lent, the Deacons purchased "A Sanctified Art" Lenten resources for people to use at home. LRUCC held a hybrid Ash Wednesday service. In addition, we held a series of Lenten lunch discussions following the worship service on three Sundays during March. The lunches featured homemade soups, provided by volunteers, as well as bread. Tables were provided with discussion questions. Discussion leaders spoke, then facilitated a discussion following the meal. Zoom participants joined in the discussions. Communion, featuring pre-packaged elements, was included in all of the worship services during Lent.

For Holy Week, LRUCC offered hybrid Palm Sunday, Maundy Thursday, Good Friday, and Easter services, supported by the Deacons. We also offered an in-person only Sunrise Service on Easter morning, thanks to Chris Weakley's able leadership.

At the end of April, the Rev. Dr. Shelli Poe visited for the weekend to meet the congregation and preach, followed by a Congregational Meeting during which LRUCC members joyfully voted to call Shelli as our new Senior Pastor. The Board of Deacons is very grateful for the hard work and dedication of the search committee.

The deacons helped with the Spring

Fling community outreach event in May. The event, funded by a Trinity Trust Grant, brought hundreds of visitors to enjoy games, activities including a petting zoo, and food trucks.

We celebrated Interim Senior Pastor Art Cribbs's last Sunday with us on Sunday, May 21, with his final worship service and a farewell picnic featuring some of his favorite foods. The deacons thank Pastor Art for his leadership during the two-and-a quarter years he served LRUCC.

After discussions in May that included off-board deacons, we resumed the practice of communion by intinction in June. During the year, we have worked on updating the former instructions. In addition, we have decided that here at LRUCC, communion servers do not need to be ordained deacons. Pastor Shelli holds practice sessions at 9:30 A.M. on Communion Sundays for communion servers to ensure that they are comfortable with their role in offering the sacrament of communion.

We celebrated Pastor Shelli's arrival on Sunday, June 11, with a welcome meal of tacos and potluck foods after the worship service. Shelli jumped right into ministry here at LRUCC. She marched in the DC Pride Parade as part of the Potomac Association contingent, along with two other LRUCC members who carried LRUCC signs and rainbow "It's Just Love" signs on June 10, the day before her first Sunday.

Open and Affirming (ONA) Sunday was celebrated on Sunday, June 25, with a number of participants involved in various elements of the worship service.

Over the summer, Pastor Shelli and the deacons discussed using more inclusive versions of the Lord's Prayer during worship. Several different versions were used during the worship service, one Sunday at a time, over the course of the summer. Members and friends of the congregation were invited to vote for and rank their favorite versions, including the original version in use at LRUCC prior to Pastor Shelli's arrival. After seeing the mixed results, including some whose top choice was the original version, Shelli and the deacons decided to rotate among the top-ranked versions during the liturgical seasons of the year, using the original version during Lent, and the most popular inclusive versions during other seasons.

We bid farewell to long-time members and church leaders Dave and Jan Curtis on Sunday, August 20.

In early September, we celebrated Rally Day and the start of the new church school year with a festive baked potato bar. Many thanks to Kathleen Styles, Rich Dodenhoff, and everyone else who helped make this shared meal a success.

The deacons recruited many helpers from the congregation for three memorial services. Susan Crandall's service was on Saturday, September 9. Fran Durocher's service was one week later on Saturday, September 16. As I write this, Dee Collin's service is scheduled for Saturday, January 13, 2024. Many thanks to everyone in the congregation who assisted the deacons in greeting, ushering, bringing food, and helping to set up, serve, and clean up for the receptions.

The deacons participated in the

community outreach Trunk or Treat event on the afternoon of Sunday, October 29. Carolyn Yocom and Caroline Labbé ran a popular pumpkin-painting event, while John and Karen Holley decorated their car and dressed up to hand out treats along the row of trunks. Like the Spring Fling, this event was also funded by the Trinity Trust Grant. It also drew hundreds of visitors to LRUCC.

Guest preachers in 2023 included Al Fuertes, Karen Byrne, Chris Weakley, Jerry Foltz, and Drew Enze.

The Board of Deacons voted to sponsor the revived Open and Affirming Ministry. We also voted to financially support the meals that members of the congregation are providing for GMU student members of the ARISE Campus Ministry led by Drew Enze.

During Advent, the Board of Deacons purchased the lovely "Maya Angelou and the Freedom Poetry of Advent" resources, proposed by Pastor Shelli, from the Salt Project for use during Sunday worship and for people to use at home.

With many thanks again to Amy Mireku, Pastor Shelli, John and Karen Holley, Carolyn Yocom, and Bruce Summers, the deacons held a hybrid Bereavement Tea and Blue Christmas service for members and friends who had lost loved ones during the year. The Blue Christmas service was open to everyone who might be in need of comfort during the holiday season. In addition to organizing the event and sending out invitations, Amy and her family also prepared and delivered tea boxes to some of the virtual attendees. while Shelli delivered additional boxes to residents at Greenspring Village later in December.

Christmas Eve fell on Sunday this year, so the deacons supported offering a pre-recorded fourth Sunday of Advent service on YouTube on the morning of December 24, followed by a joyful hybrid Christmas Eve Service at 5 P.M. that included the baptism of Miller Owen Ward, the great-grandson of longtime members Owen and Meg Thomas. Owen Thomas participated as an off-board deacon, since he had been an LRUCC deacon for many years.

The deacons continue to struggle to find worship volunteers. We continue to need ushers, and, normally on the first Sunday of the month, Communion servers. Last year Drew Nettinga had hoped to restart the ushering teams, but to date, not enough people have been interested. We also continue to need recorders for Thanksgivings and Concerns. Carrie Douglass and Ellen Wertman would both really appreciate it if others would join them in volunteering for this important task. Please also consider volunteering to usher and to serve communion.

Pastor Shelli set up a community care team to assist her with calling, visiting, and sending cards to people in need of prayer and friendship.

This is a very small team that could use more members. Please consider volunteering to join the team to ease Shelli's burden as a solo pastor caring for a large congregation.

Thanks to Kathleen Styles, the coffee teams are running smoothly. Everyone enjoys fellowship over coffee or tea in the social hall following worship. The coffee teams can always use more volunteers. Join a team, or join the list of substitutes. It's a fun way to get more involved in the life of LRUCC.

Finally, many thanks to the small but mighty group who make up the Board of Deacons! We look forward to new members joining us in February. We are grateful to Steve Wheelock for agreeing to join us and to represent the deacons on the Strategic Planning Committee in 2024.

Outreach and Social Justice

From Little River UCC's constitution: "The Board of Outreach and Social Justice shall oversee the outreach ministry of the Church, shall organize the outreach to the local community, nation, and the world, and shall make recommendations for missionary apportionments and the allocation of benevolences. The Board shall promote social justice by engaging the congregation in meaningful dialog, mission work, and faith-based action....shall also oversee the use of the income from the Thelma Morris Fund which shall be used to pay the

costs of participation, by members or friends of the church, in mission projects...."

January: The Justice and Witness Action Network (JWAN) of Virginia, UCC Potomac Association, voted to continue to work on elimination of solitary confinement as well as advocating for the proposed constitutional amendment to remove the same sex marriage ban from the Virginia Constitution. The constitutional

amendment was not supported by the governor or the House of Delegates; there were some positive changes in the effort to curb solitary confinement as a practice in Virginia prisons.

February: Gay Gardner arranged

for Kevin Williams and his mother Chrisdeon Cofield to speak during the worship service on February 26 about the trials of solitary confinement in the Virginia Department of Corrections. Although solitary confinement has been abolished, forms of it remain today to the detriment of those confined in Virginia prisons. The heartfelt testimonies of Mr. Williams's and Ms. Cofield's were moving and may provide impetus in efforts to provide legislative solutions to this problem.

March: The One Great Hour of Sharing offering was collected March

19. OGHS "supports the disaster, refugee, and development ministries of the United Church of Christ within Wider Church Ministries." Little River has a long history of being "Five for Five" in the offerings of the church, which includes four special offerings and Our Church's Wider Mission contributions.

April: The Easter offering was again used to fund a Rise Against Hunger meal packaging.

May: Postcarding under the aegis of JWAN continued for the primary election. Fifteen people drafted 520 post cards to Chesapeake minority voters, encouraging them to vote in the primary election. The Center for Common Ground is the non-profit that provides the text, names, and addresses.

A few members attended a showing at the Angelika Film Center of *Gabby Giffords Won't Back Down*. Ms. Giffords and Mark Kelly have worked tirelessly to promote gun safety in the U.S. since her near-fatal injuries as the result of a shooting.

Another special offering of the UCC, Strengthen the Church, was collected on May 28. The offering supports the work of our Central Atlantic Conference and the national UCC. The offering funds leadership development, youth and young adult ministries, and new and renewing congregations.

June: BOSJ assisted the Honeysett family during the coffee hour on June 18 for the UCC Open and Affirming

Sunday. There was an array of rainbow colored foods, and BOSJ purchased some UCC pins celebrating LGBTQ+ people and distributed them during coffee hour.

July: Carter Wilbur brought *The Hunt*, a Cypriot-produced short film with biblical and LGBTQIA+ issues on August 6. The showing was attended by about 25 in person and several more by Zoom. *The Hunt* is a haunting portrayal of a father whose gay son presents an extreme moral dilemma for the father, reminiscent of the Abraham and Isaac story in our Christian Bible.

The Board sponsored backpacks for students for Second Story and Neighbor to Neighbor. We collected 22 backpacks for N2N (with no supplies) and about 20 more backpacks filled with supplies for Second Story.

September: Eighteen people sent 650 postcards to encourage people of color to vote in the General Election in Virginia.

October: Rise Against Hunger was a wonderful intergenerational event on October 1 in which members and friends packaged 10,000 meals. We learned that the meals were sent to feed refugees in war-ravaged Ukraine.

Neighbors in Need, another UCC special offering, was collected on October 1 by UCC congregations, including Little River. One-third of the offering supports the Council for American Indian Ministry and two-thirds are used by Justice and Witness Ministries which provides grants to UCC churches and organizations. Other support goes to a variety of justice initiatives and service projects.

The Board participated in the Trunk or Treat on October 29 by staffing the ring toss on the witches' hats.

December: The Christmas offering was collected. Traditionally, 50 percent of the money goes to the *Page 12*

Veterans of the Cross, and BOSJ voted for 50 percent be designated for the UCC H.O.P.E. fund for international emergencies.

Additional News

A large effort of the board beginning in the fall is to coordinate the giving of gifts to three centers: ACCA Child Development Center, Main Street Child Development Center, and Shaw Community Center. This involves printing out tags with each child's wishes, collecting signups, sorting, and then delivering the gifts to the three centers. A special thank you to Lolly Easley for coordinating this effort. We breathe a sigh of relief when all tags are accounted for! This year we were particularly pleased to have the church return to a separate service on December 10 participating in the ages-old story of the magi presenting gifts to the newborn Christ child. The congregation generously supported gifts for 50 children from Main Street Development Center, 75 from ACCA Child Development Center, and 29 from Shaw Community Center.

The benevolences from the Endowment Fund money for 2023 (\$10,400) were approved by the Church Council in the amounts of \$3,000 to F.I.S.H., \$3,000 to Faith Alliance for Climate Solutions (FACS), \$3,000 to Second Story, \$1,000 to Congregation Action Network, and \$400 to Virginia Center for Interfaith Public Policy. The benevolences from Little River's annual budget were voted on by BOSJ and dispersed to the following: \$1,000 to Fairfax County Public Schools for the Restorative Justice program, \$750 for Neighbor to Neighbor, \$3,000 to F.I.S.H., \$3,000 to FACS, \$3,000 to Second Story, \$200 to Virginia Center for Public Policy, \$1,000 to Black Church Food Security Network, and \$1,000 to Friends of Guest House.

In addition to other activities, we

need to highlight Neighbor to Neighbor, in which we participate with three other churches: Peace Lutheran, Ravensworth Baptist, and John Calvin Presbyterian. Janet Parsons Mackey is our driving force in this effort to assist in outreach to Afghan immigrants. Those Afghans who arrived in the evacuation have become more assimilated into the wider northern Virginia area and now gather (along with newcomers) for informative workshops. The group is establishing a 501(c)(3) organization, led by Afghan colleagues with the support of representatives from the four churches. If anyone is interested in assisting in tutoring, English classes, or developing a relationship across cultures, contact Janet Parsons Mackey.

Fair Trade has continued to offer chocolate, coffee, and Palestinian olive oil for sale on various Sundays. While it falls under BOSJ's umbrella, the volunteers order products and respond to the congregation's wants. A basket was available in November to collect additional offerings to support a hospital in Gaza that was bombed during the Israel-Gaza war.

We continue to recruit volunteers for phone captains and drivers for F.I.S.H., and keep an eye on the food pantry. The board has discussed whether the food pantry is where we should put our money and time as a church, but we are deferring action until strategic planning has taken place.

A special thank you to Emily Leary Chesnes for being assistant chair this year and providing essential backup. The chair also wishes to thank everyone on the board for helping with this important work of our congregation and the church of Jesus Christ. I have learned in my first term that BOSJ is a very busy board. If anyone is nudged by God (to use a phrase of Janet Parsons Mackey) to join in this work, contact Nominations and Appointments.

Christian Education

Faith formation is thriving at Little River. With 2022 being a year of renewal, 2023 has been a return to full programming with many new families and adult participants.

Adult Education

• Antiracism: In the spring of 2023, four members of LRUCC participated in the Confronting Whiteness course with Ravensworth Baptist Church. The Board of Christian Education (CE) supported this by paying half of their fees from the Ralph Wands fund. The four participants shared their learning during a coffee hour discussion on June 4. About 20 members participated in the course that Pastor Shelli led about *How to be an* Antiracist during the summer of 2023. Currently the CE board is supporting the development of the Antiracism

Ministry and has approved \$5,000 from the Ralph Wands fund as a stipend for Pastor Darryl! Moch for his consulting services in 2024.

 Monday Morning Religious Studies Class: The Monday Morning Religious Studies class successfully hosted weekly lessons and discussions in a hybrid format in 2023. In January 2023, CE approved and purchased The Fall of the Pagans and the Origins of Medieval Christianity from Great Courses. The Mon-





day Morning class has enjoyed this course as well as the Buddhism course and others in 2023.

- Pastor Shelli meets monthly with the Progressive Christian Fellowship at Greenspring and attendance has been 10–15 people.
- Pastor Shelli provides adult Christian Education through

her Tuesday Discussions, offered quarterly on Tuesday evenings. This summer, she offered a course on *How to be an Anti-racist* that incorporated Black Theology. This fall Pastor Shelli

offered a course on Feminist Theology. She will begin Womanist Theology in January 2024.

Church School

2023 Church School Teachers: Karen Kleiber, Carolyn Yocom, Heather Shackley, Jane Wallace, John Mingus, Natalie Stapert, and Gail Perry.

A special thank you to Pam Binninger, Susan Kennedy, and Ashton Streavig for filling in when needed!

• We utilized a "one-room school-house" approach in the summer of 2023, which meant the nursery, elementary class, and youth class all met in the same room to ensure that safe church guidelines

were always followed.

• With Pastor Shelli's support, CE developed a continuum of Christian education from nursery through confirmation and beyond. Each Sunday, we offer Godly Play in the nursery, an elementary class for grades I-4, and a youth class for grades

- 5–12. Our elementary class averages about 6–7 students per week and the youth class often has around 10. Pastor Shelli is teaching a confirmation class weekly for a group of youth in grades 8–12.
- CE hired Mia Morgan in August 2023 to join Yris Saenz in the nursery. Yris and Mia offer childcare from 9:30 A.M. to noon on Sundays and during special events. It's wonderful to see the nursery operating again, and there are usually 2–4 children on Sundays.
- In the fall of 2023, CE provided Bibles to 12 children and youth. CE will work to maintain a regular schedule of giving Bibles to new babies, children in PreK/K, and children in 3rd and 4th grade. CE would also like to provide Bibles to our youth, and that is in the works for 2024.
- In November 2023, Seasons of the Spirit, our long time elementary church school curriculum, was discontinued. The elementary teaching team has evaluated curricular options suggested by Pastor Shelli, and will begin teaching lessons from Progressive Christianity's Joyful Path curriculum on January 7, 2024. Funds from 2023 have been used to purchase curricular materials.
- The LRUCC Youth group for youth in grades 7–12 is continuing to get established and build connections among the youth. This year the youth group has participated in Rise Against Hunger, the Trunk or Treat event, and participated in a laser tag outing. The youth will continue to gather once a month to build community.

Board of Trustees Responsibilities

The Board of Trustees portfolio of responsibilities include: care and management of our building and grounds; church office operations and equipment; building and grounds security; use of the church building and sanctuary (in consultation with the Board of Deacons); and church finance and budgets (in partnership with the LRUCC finance team).

2023 was an extraordinary year; Rev. Shelli M. Poe was called by the LRUCC congregation to be just the fourth settled pastor in LRUCC's history. For the Board of Trustees that meant additional projects to accomplish including sprucing up the building and grounds; helping Pastor Art move out; setting up Shelli's office; and supporting all the special church events around our pastoral transition.

Building and Grounds Manager

In March, Little River church bid farewell to our sexton Nicole Renzo when she moved to Blacksburg, VA, and the search was on for a new building and grounds manager. Bill Huddleston stepped in as an interim building and grounds manager from March through early October, admirably managing the ongoing maintenance projects, ongoing fire alarm system installation work, and the transitioning of senior pastors. During his tenure, Bill undertook a major cleanout and refurbishing of the downstairs storage rooms, sexton office, and boiler room/

workshop (which now includes a rainbow flag-themed tool storage system!)

On September 25, Chris Di Mascio joined the staff of Little River UCC as full-time Building and Grounds Manager. Chris's first Sunday at Little River was October 1. His first week here was especially eventful with fallen tree issues, sprinkler system inspection, pest control, and support for church events. Chris has more than 30 years' experience in facilities and grounds maintenance including military housing at Quantico and facilities and housing at the Navy Yard, Naval Research Lab, Naval Observatory, Annapolis, and Bolling Air Force Base. Prior to joining the LRUCC staff, Chris worked from 2009 as Engineering Manager at the Vinson Hall continuing care retirement community in McLean, VA, where he was responsible for all phases of maintenance for a five-building campus. Chris is skilled in electrical and plumbing work for home construction and remodels and has certifications as an HVAC technician and for preventive maintenance of building systems.

Building Improvements in 2023

• In June, the solar screens were installed in the sanctuary. This was the happy conclusion of a nearly yearlong effort to replace the old and deteriorating draperies. The fundraising effort for the sanctuary solar screens was a great success! The total cost of

the project was \$21,579, which included \$4,626 for the electrical work and \$16,953 for the screens. Members of the congregation generously donated \$16,355. The balance of the total cost, \$5,244, was paid from a grant from the Endowment Fund, which was approved by the congregation at the Annual Meeting in February

Also, during the summer, \$1,500 in expenditures from the Capital Expense Reserve were made to pay for a TV monitor in the narthex, plus cables, mics, and other equipment to enhance online streaming of worship, as well as provide overflow capacity for persons seated in the narthex to view and hear the worship service.

Building Maintenance

Compared to the previous year, 2023 was a much easier and significantly less costly year for repairs and major equipment replacement. Following is a list of major building repairs and maintenance projects completed in 2023:

- In January, defective ignitors and ionization electrodes were replaced on the church's two boilers for a total cost of \$858.
- Thermostats for the Social Hall and Rooms 7 and 8 were repaired. In July, the actuators for the sanctuary humidity control system were adjusted and the sanctuary thermostat was replaced. The total combined cost for these projects was \$1,029.
- The most significant maintenance project of the year occurred in June, which was replacement of the boiler pump assembly, pump motor, valves, and gaskets for the church boilers. The boiler pump assembly was

the original equipment, so it had served the church for almost 60 years. The total cost for this work was \$6,057 paid from the Major Repair Reserve.

- In October, the water supply line to the dishwasher failed very dramatically during
 - Sunday morning coffee hour clean up. Fortunately, the dishwasher itself is fine. Only the water supply line needed replacement for a cost of \$318.
- A new cleaning and janitorial contractor, Clean Methods, started work in April 2023, cleaning both the Annandale Cooperative Pre-School and the church areas. This relationship is working well. Clean Methods has provided specialty spot cleaning where needed and stripped and waxed all the tile floors in the building in June.

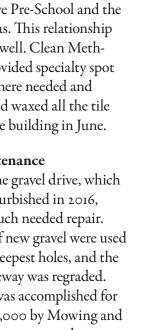
Grounds Maintenance

• In April, the gravel drive, which was last refurbished in 2016, received much needed repair. Five tons of new gravel were used to fill the deepest holes, and the entire driveway was regraded. The work was accomplished for a cost of \$2,000 by Mowing and Towing, the company that mows



- Improvements were made to the Memorial Grove area with the addition of several new benches that were assembled by staff and David Roach, before the two memorial services in September.
- Dead and dying trees continue to be a problem on the church grounds. In October, five trees were removed by Fito and Sons, a new contractor for LRUCC. One tree was a dead tree that fell in the parking lot, one was a dead tree in the playground, and the others were large dead trees threatening the parking lot, preschool path, and nature path. The total cost for all removals was \$5,800.
- In October, LRUCC was awarded a Tree Protection and Preservation Fund (TPPF) mini-grant of \$3,000 for removal of invasive trees and vines. LRUCC contracted with Residential Reforestation LLC for removal of Tree of Heaven (Ailanthus,

Little River UCC Annual Report 2023 host for the spotted lantern fly) and porcelain berry vines on the church property. In November, Chris Mourlas of Residential Reforestation treated 12 *Ailanthus* trees on the church grounds with injected herbicide. It will take about 10–12 months for the *Ailanthus* trees and root systems to die, at which point they can

be removed. Porcelain berry vines will be treated in June/ July 2024.

Fire Alarm Control Panel and Alarm System Upgrade

Work on the fire alarm system is nearing completion. Hopefully, the installation will be completed, the system tested, and an operating permit approved by the Fire Marshall in early 2024. The total cost is \$42,166 (\$38,520 from original April 2022 contract plus \$3,646 from July 2023 add-on required by the Fire Marshall). In April 2022, \$12,523 was paid as a down payment, so the balance due upon completion is \$29,643. The balance due will be paid with the current balance of \$8,391 in the Building Fund and \$21,252 from the General

Fund of the church. (In August 2022, the Board of Trustees authorized the transfer of General Funds of the church to pay any balance due on the fire alarm system not covered by the Building Fund.)

Future Considerations

The following is a list of needs that have been under consideration by the Board of Trustees during the past 12–18 months.

 The carpet in the office/conference room area is worn, stained, and in need of replacement. The carpet was cleaned in late 2021, and at that time, it was acknowledged that the carpet is overdue for replacement.

 In 2023, the Board of Trustees and other church members discussed ways to address the urgent need to expand the capacity of the memorial stone in the Memorial Grove. These

discussions are ongoing into 2024. The Board of Trustees will also explore options for landscaping the Memorial Grove to improve access to the site, address erosion, and improve the overall appearance. The goal of the discussions is to provide proposals for consideration by the congregation in 2024.

 The pitched, shingled roof experienced leaks in 2022 in the areas above the church attics.
 The leaks were addressed with spot repairs, and no further leaks were observed in 2023. However, the shingled roof is reaching the end of its life span. The roof was inspected in 2021 and determined to have about 5 years of life remaining. If the church is also interested in future installation of solar panels, the roof would need to be replaced at the same time as a solar system is installed. Either a new roof or

- solar panels would be a substantial investment by the church that would likely require external financing.
- The asphalt driveway and parking lot continue to deteriorate. The Board of Trustees sought estimates for repaving the driveway and parking lot in late 2021. There is a range of approaches and costs for repaying the parking lot and driveway and improving the side drainages, from approximately \$90,000 to more \$200,000. This would also be a substantial investment likely requiring outside financing.

The Board of Trustees invites members of the

LRUCC community to share concerns and ideas about stewardship of the church's building and grounds. The church building and grounds are integral to the ministries and outreach of Little River United Church of Christ and together comprise the largest tangible asset of LRUCC. The current insurance valuation of the church is \$6,227,717. As part of the upcoming strategic planning process, the Board of Trustees will explore ways that our building and grounds assets might best support the mission and goals of Little River United Church of Christ.

Communications

The mission of the Communications Committee is to help provide LRUCC members, staff, friends, and the wider community with consistent and comprehensive information about all aspects of church life.

In previous years, Committee members were involved in some writing, editing, and proofreading tasks for church

printed material as well as the website. These functions are now handled by paid staff—the Director of Communications Craig Stapert, and our Assistant Jay Shackley.

Some reserve funds in the Communications operating budget (approximately \$4,000) have been used to create a 9-month project for a Communications Assistant to be hired for a 20-hour-a-week job consisting of



being available every Sunday from 9 to 11 A.M. to work on the media crew, to work on the website to make it more modern and "outward-looking," and to increase our presence on social media.

At a meeting Rev. Shelli attended, she told us she would like us to publicize other local events and also to partner with other organizations on various events. She told us LRUCC's goal should be to "Do good things and tell other people about them."

When publicizing events like the "Spring Fling" and "Trunk and Treat," Committee members have posted events to neighborhood listservs, to "Open Door," and handed out flyers. We have advised Craig on banners to put out on the highway and also posters and flyers. Both "Spring Fling" and "Trunk and

Treat" events were extremely well-attended—there were hundreds of people we have not seen at the church before!

There is also informal providing of information to fellow church members on letting them know that Craig requires explicit information on what is needed for each event—two weeks ahead for a small event and six weeks ahead for a large event.

Endowment

The Endowment Fund market value increased substantially in 2023: from \$586,859 on January 1 to \$645,689 on December 31. Donations added to the fund totaled \$10,350, and expenditures were \$26,000. Note that the market value does not include \$9,000 that was mistakenly withdrawn in December. The withdrawal will be reversed in January, so the market value should be \$654,689. The net change, up about 11%, was in keeping with the stock market performance (Dow Jones up 12%). The Committee continues to believe that investing endowment monies in the stock market is appropriate for the long term.

In accordance with the Endowment Fund Policy, the Committee had determined in 2022 that \$26,000 would be available for use in 2023. At the 2023 Congregational Meeting in January, the Congregation approved using \$5,200 for the operating budget

(to be used by the Trustees), \$10,400 for outreach (to be allocated by BOSJ), \$2,600 to be used for scholarships (also allocated by BOSJ), and \$7,800 to be used for Innovative Ministry or Special Capital projects. At the 2023 Annual Meeting, the congregation decided to use the amount allocated for Special Capital projects, \$7,800, to help pay for new blinds for the sanctuary.

The blinds were paid for in June. The funds for the Operating Budget (\$5,200) were used in October. Also in October, Bosj proposed using the scholarship funds for the UCC Pension Board's Ministers Financial Vitality Initiative (MFVI). After getting approval of the Church Council, \$2,600 was sent to the MFVI. In December, Bosj proposed using the outreach funds to assist five local organizations. After getting Church Council concurrence, \$10,400 was disbursed in December.

The Endowment Committee recommends making \$28,000 available for use in 2024. In accordance with the Endowment Fund policy, \$5,600 should be used for the operating budget, \$11,200 for outreach (as designated by BOSJ), \$2,800 for scholarship (also designated by BOSJ), and \$8,400 for Innovative Ministry or Capital Projects. There are not yet any specific recommendations for the outreach, scholarship, or innovative ministry/capital project funds.

The Endowment Fund of Little River UCC continues to provide a great opportunity for memorial gifts, for recognition of the importance of the church in your life, and for making a lasting contribution to the important ministries of the church.

Music

The chief responsibilities of the Music Committee are to support the music ministries at Little River and to work with the Worship Committee to plan and conduct worship services throughout the church year. Specific activities in 2023 are described in the respective reports of the Director

of Music and Communications and the Deacons, who oversee the Worship Committee, and do not need to be duplicated here.

Tracey and Brian MacDonald were appoint-

ed to the committee after the annual meeting, which made the committee fully staffed. The two committees met together throughout the year, essentially functioning as one body.

Several musical ensembles perform during the academic year from September through early June. These include the Sanctuary Choir, for adults; the Bell Choir, for people of all ages; the Youth Choir (also known as Joyful Noise) and the Children's Choir (also known as Salt of the Earth). Craig Stapert ably leads the Sanctuary and Bell Choirs while Ashton Streavig leads the Youth and Children's Choirs.

During the year, the Sanctuary Choir performed a *Mass* with organ and choir by Vierne on March 26, 2023 and on December 17, they performed Vivaldi's *Gloria*. In addition, on August 18, they performed a piece written by Hube E. Beckwith, as a farewell to Jan and Dave Curtis as



they left the Northern Virginia area to move to Annapolis, MD. At other services during the year, instrumentalists, both church members and paid guests from outside the church, played. Over the summer, Craig Stapert coordinated with various smaller ensembles to perform during the service.

An appraisal of the musical instruments owned by the church was submitted to the Board of Trustees to assist in ensuring that the instruments are covered should an unforeseen circumstance happen to them. The trustees are exploring insurance options.

As always, all of the ensembles would welcome the participation of new and returning members.

The Nominations and Appointments Committee (NANDA) is responsible for appointing people to fill mid-term vacancies and securing nominations of individuals to serve as officers and on boards and committees who are then voted on at the annual meeting in January. This work is ongoing throughout the year, consulting with officers, chairs of all the boards and committees, and the Senior Pastor.

Under current church bylaws, the NANDA Committee should have 5 members appointed by the Church Council. We are currently understaffed, and we will lose another member in January 2024. As in previous years, committee members reached out to prospective candidates through email, conversations, and phone calls. In addition, committee members wrote several appeals, published in *Current Reflections* and in weekly church communications.

This year the committee worked on updating all the descriptions of each board and committee to include the task and time requirements for each group. We attended new member classes with the pastor to highlight opportunities for service to new members just joining the congregation. We consulted with our pastor, council leaders, and our greeters to seek out eligible candidates. With the help of our communications staff, we have updated the Leadership Roster and prepared the ballot of prospective volunteers for the Annual Meeting in January 2024.

The Committee is grateful for the many volunteers who devote many hours of service to support and carry out the ministries of our church. The Committee is always open to ideas and suggestions from everyone in our congregation to help further our work.

2023 Programs and Activities

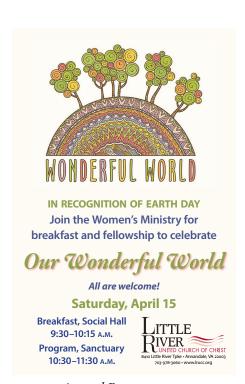
April 15: It's a Wonderful World! Earth Day Program (26 Attendees)

This hybrid program (in-person and on Zoom) open to all who wanted to attend, began with a light breakfast in the social hall with the program being held in the sanctuary. Steve Wheelock participated in leading participants through a responsive reading of the powerful and beautiful Haudenosaunee Thanksgiving Address, Greetings to the Natural World. Little River UCC

The program continued with Scripture and poetry readings, a hymn, and a video and sing-along of Louis Armstrong's version of "It's a Wonderful World." This was followed by small group discussions focused on ways to preserve and protect the earth and our natural environment.

While recorded music played, participants were invited to light a candle, and then a video of Amanda Gorman reading her poem "Earthrise" was shown. The program ended with a Franciscan prayer from "Caring for Creation: 11 Nature Prayers for Earth Day" read as the benediction.

August 6: UCC Climate Hope Intern at coffee hour

Pastor Shelli asked the Women's Ministry Team to support Jesse Dolojan, an intern working with the UCC Climate Hope internship Program. Jesse asked members of our congregation to sign environmental petitions from the UCC. The Women's Ministry made sure there was a table set up in the choir area of the social hall for him. Many members signed petitions.

September 10: Rally Day

The Women's Ministry participated in Rally Day with a table and poster display at the coffee hour. The poster held many wonderful photos of past programs and breakfasts that WM sponsored. Bunny Jones is the unofficial archivist of the Women's Ministry, and we are grateful for her help in making a poster.

Karen Flann created, and made available at the table, a questionnaire asking members for feedback on ideas for future programs. WM got a good response.

September 17: Moment for Mission at the service

Pam Binninger, a long time Women's Ministry Team member, volunteered to talk about the Women's Ministry Team at the service. Pam spoke about the mission of WM nurturing fellowship and spirituality among Little River women and friends. She highlighted the different programs that WM sponsors; however,

most importantly, she expressed the relationship building and the opportunities for meditative and quiet reflection WM sometimes offers, not only to the women of LRUCC but to all of the congregation.

October 29: Trunk or Treat"

Women's Ministry members participated in the church and community wide Trunk or Treat held along a church driveway. Jane Wallace decorated her vehicle and Karen Flann assisted with giving out treats. Pam Binninger and Carrie Douglas oversaw one of the cornhole games in the church.

November 11: "What Feeds Your Spirit" (24 Attendees)

This Saturday morning program consisted of a generous continental breakfast and coffee. Attendees sat at tables of four, and there were discussion cards at the tables asking two questions: "What Feeds Your Spirit?" and "How can you say 'No' to things that deplete your spirit?" There were good discussions around these conversation questions but also time for socializing.

Pastor Shelli introduced the program and questions as well as information from Professor of Biology Paul Fitzgerald, Ph.D., at NVCC, the co-coordinator of the Annandale Center for Contemplative Practice (ACCP). During November, the center offered an online opportunity called "Put the NO back in NO-vember!" Participants received daily emails for the month about the joys and struggles of saying "no" and the importance of boundaries as a practice in self-compassion. Pastor Shelli thinks this could be a good collaboration going forward, and the Women's Ministry Team will explore further.

brought to the Women's Ministry Team's attention that there were a very large number of donated ornaments from Fran and Siggi, dear and deceased members of the church. - November 12 Women Talking by Miriam Toews led by Caroline Labbé

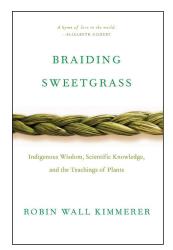
2024 Book Group

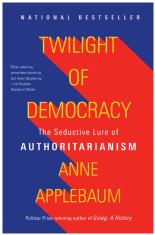

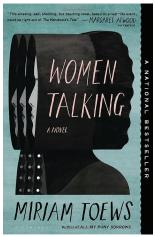
Looking forward to 2024

Meetings of the Congregation:

Congregational Meetings were held on February 5, April 30, and November 12 in 2023.

The January meeting constituted the traditional annual meeting of the congregation and included reports from committees and boards. Significant announcements and actions during the meeting included:

- The search for a new pastor was reopened.
- The membership section of the bylaws (Article VII) was amended to simplify the process of removing inactive members.
- The new Safe Community Policy was adopted.
- The endowment fund would provide the money to purchase new blinds for the sanctuary.

All nominees to serve on committees and boards were unanimously approved. The congregation approved the distribution of disbursements from the General Endowment Fund for 2023, and the 2023 Operating Budget was approved.

At the April congregational meeting, the Rev. Dr. Shelli M. Poe was called to serve as the congregation's senior pastor effective June 5, 2023 under the provisions in the call letter dated April 3, 2023.

The November congregational meeting was for informational purposes. The Rev. Poe discussed strengthening LRUCC's ties with the UCC Fredericksburg congregation and hiring their pastor, Rev. Darryl! Moch, as a consultant to Little River's antiracism ministry. An update was given on the stewardship campaign, and a preliminary budget for 2024 was discussed.

All of the congregational meetings were held both in person and online.

Meetings of the Church Council:

Except for August, the Church Council met monthly during 2023. One additional meeting was held in each of the months of February and March.

Council met online for the most part but held three in-person meetings.

Flower Report

Troop 1532 Highlights -2023

As a component of the Youth Ministry programs at LRUCC, the church through the Board of Deacons is the Chartering Organization (sponsor) for Scouts USA Troop 1532 and Cub Scout Pack 115. Scout program years are equivalent to school years with

the summer added for Scout Camps, High Adventure Camps, and canoeing, kayaking, bicycling, and other outdoor activities. Troop 1532 is now in its sixth program year at LRUCC.

The Troop and Pack wish to thank LRUCC for being the Chartering Organization for both Troop 1532 and Pack 115, and they appreciate the continued support.

2023 was the first year since the pandemic that there were no limitations on the program activities, and both the Troop and the Pack had full and active program years.

In March of each year is when 5th grade Cub Scouts transition from Cub Scouts to Scouts USA. In addition to Cubs from Pack 115 "crossing over" to Troop 1532, Troop 1532's reputation as a great troop continues to grow, and Cubs from Pack 1534 also joined

Troop 1532 in March 2023. In addition, several senior Scouts, who have friends in Troop 1532 and appreciated the level of Scout leadership and adult mentorship, have transferred in from other Troops.

Two Scouts earned their Eagle rank in 2023: Sean Conley and Eli Fugate.



Sean's Eagle Project was the "Spiritual Nature Trail at LRUCC," which is a quarter mile trail starting at the northwest corner of the parking lot, looping through the woods, crossing a stream, and ending at the LRUCC Outdoor Worship Area. Eli Fugate's Eagle Project used a GIS mapping system to optimize trash pickup for a neighborhood in Washington, D.C. In addition there have been four additional Eagle Scout projects un-

dertaken in 2023, although the Scouts have not yet had their Eagle Boards of Review. One Eagle project was improving the trail at Camelot Pool to make it safer by installing solar lights; one was the building of an activity table including chess, checkers, and a memory game for an Annandale

Memory Facility; and one was improvements at the Hidden Oaks Nature Center.

Worship Related Activities

Scout Sunday is traditionally celebrated in February of each year, but in 2023 LRUCC celebrated it during April. The reason was to have the Outdoor Worship Area dedication included as part

of the farewell weekend for Interim Pastor Art Cribbs. Pastor Art's name was also added to the Troop 1532's Honor Plaque in the VIP Column as the Troop's "COVID Pastor."

At the September Court of Honor, Pastor Shelli Poe was welcomed as the new senior pastor and presented with a plaque from Troop 1532 highlighting the five years that LRUCC has been the Chartering Organization, and she was also given a Troop 1532 T-shirt.

Troop 1532 Outdoor Activities and Service Projects

The reason for the combined heading for this topic is that all Troop Outdoor Activities incorporate a service element—it's not just "Leave no Trace," but rather "Leave it Better Than You Found It!" Here's just a partial list of the Outdoor activities and service projects the Troop undertook

in 2023: Annual Accotink Creek cleanup on MLK day—removed 500 pounds of trash; February Troop Ski trip to Ski Liberty; Scouting for Food drive; and the May New Scout Campout. Troop 1532 always participates in the LRUCC outdoor cleanup days.

Troop 1532 does not slow down during the summer; if anything, the level and duration of activities increases, including

the annual week-long summer camp at Goshen Scout Reservation; sending a crew to the National High Adventure SeaBase; and the annual Troop 1532 High Adventure 50 Miler Canoe Trip on the Upper Potomac. The 50 Miler Award has a significant service hours component built into it, and this year, Tom Hall, the mayor of Bath, West Virginia, thanked the Troop 1532 Scouts at a Town Hall meeting for their service project benefiting Bath.

In December, the Troop participates in the Wreaths Across America Remembrance at Arlington National Cemetery, and it is one of only a few youth organizations that are given responsibility for a tractor trailer with wreaths at ANC (most of the 56 groups are adult groups). Between 5 A.M. and

noon, Scouts prepared, organized, and oversaw the distribution and placement of 3,845 wreaths at ANC.

Cub Scout Pack 115, Contact: Shannon Novack, Cubmaster

In Cub Scouts, there are dens for each grade level, from kindergarten to fifth grade.

• Kindergarten—Lions



- First grade—Tigers
- Second grade—Wolves
- Third grade Bears
- Fourth grade Webelos I (stands for We Will Be Loyal Scouts)
- Fifth grade (Arrow of Light).

Fifth graders transition to the Scout Troop in the spring of their fifth-grade year, and the AOL Scouts joined Troop 1532 in March 2023 in the "Crossing Over Ceremony."

Pack 115 Activities

At the Cub Scout level, camping is done family style, and Pack 115 traditionally has a spring and a fall campout, including the fall campout at Burke Lake Campground and the spring one at Lake Fairfax Park. In addition, older Scouts (Webelos and AOL) can go to Camp Ross at the Goshen Scout Reservation in July.

Each January, the Pinewood Derby is held, and also during the winter, the older dens go to for an overnighter on the USS Torsk submarine in Baltimore Harbor. The Raingutter Regatta boat race was held during the

fall. At Pack events, we had the honor of hosting guests from the Annandale Fire & Rescue Squad; for our October meeting we visited the Turner Farm Observatory in Great Falls. At Pack and Den Meetings, Cubs learned new sports, practiced healthy meal planning and cooking, sang silly songs, and tied lots of knots.

Pack 115 Service Projects

In service to their community, Cub Scouts participated in Scouting for Food, the LRUCC outdoor cleanup days, and Accotink Creek clean-up activities. In addition, Cubs from the Webelos and AOL dens participate several times a year in joint activities with Troop 1532 Scouts. This is designed to give the boys an opportunity to meet each other before the Crossing Over ceremony in the spring. Day hikes along the Accotink Trail and the Billy Goat Trail are examples of this.

Annual Mulch Sale

Troop 1532's annual and only fundraiser is the mulch sale held each March. The Troop thanks everyone in advance for their continued support of Troop 1532!

Treasurer's Report

Summary

As of December 31, 2023, Little River had available cash of \$174,591. The total value of investments was \$734,350 (book value), with a market value of \$1,050,230. Cash liquidity was strong this year. **Further strengthening the church were generous contributions from members and friends.**

Little River ended its 2023 operating budget with a deficit of \$13,913. Our original budget anticipated needing to use \$40,000 in funds from previous years, so limiting this spending to \$13,913 is good news. Overall, we collected \$2,266 more than anticipated and spent \$23,756 less than budgeted.¹

A Programmatic View of Our Spending for 2021 through 2023

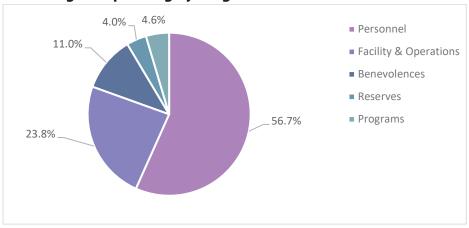
